## CHAIRMAN

What a season!! Andrew Shelley recruited so many new umpires they could barely fit in his training room! The upshot is we have regularly had umpires across all 5 grades, something of a novelty this century (and rare-as could be last one). Should such recruitment be repeatable, we'll have a surfeit, for the first time ever.

The number of new umpires has taxed the Appointments Panel to balance the priorities of Cricket ACT, and the need to partner newer umpires with more experienced colleagues.

Our representative umpires performed very well in a variety of matches and represented the Council with distinction. Dinusha Bandara made his Futures League debut, with the wily Yohan Ramasundara as partner, to assist in his successful transition to more senior umpiring – a good job well done by both. Some of the newer representative umpires were able to stand in the Women's Big Bash League matches, an experience not often come by, and hopefully Cricket Australia may be kind enough to permit such appointments to continue. All representative umpires received generally positive feedback from the captains in these games.

The season prelude was the annual seminar, splendidly organised by Andrew Shelley and his team. Bob Parry of Cricket Australia gave an informative overview of the new on-line accreditation process, which we all need to complete. The ebullient Darren Goodger, well known to many of us, regaled us with tall tales and true, with lessons for all of us. He also continues to present to the representative umpires, a commitment much appreciated.

The Council appreciates the ongoing cooperative approach Cricket ACT applies to its relationship with the Council. Ben Ryan as Cricket Administrator continues to provide the Council with much support and assistance, of great value to those of us who deal with him. Cameron French, in his first season as CEO, has engaged cooperatively and proactively with us. We have made some headway towards a funding model for first grade scorers, though the details are yet to be nussed out. His predecessor, Mark Vergano, has been kind enough to become Umpires' Observer, and has proven to be most adept in his new role, perhaps unsurprisingly, given his varied background! Andrew Dawson and Dougal Reed, having been great supporters of the Umpires & Scorers have recently moved on, and merit our best wishes after all their assistance.

At the ACT Cricket awards night the Greg Lord Administrator of the Year award went to our very own long-serving Finance Officer Andrew Koprass. The award is named in memory of Greg Lord, former Executive Director of the Association, and a former captain and president of the East Canberra Cricket Club (and after whom the Greg Lord Pavilion at Kingston Oval is also named). This prestigious award was previously presented to former legendary umpire Brian Lawrence.

Good governance is the lynchpin of any successful organisation, and whilst we are a Council of ACT Cricket, we still retain obligations for our own body. The Executive has had numerous discussions around such matters, and we continue to propose minor adjustments to the Standing Minutes as appropriate to our requirements. Also, our financial position remains sound, under the diligent stewardship of Andrew Koprass, and we continue to look at prudent use of funds available, to benefit our members.

I would like to congratulate those achieving the Council's Awards for the season, named elsewhere. Of special mention is the Kevin McCarty medal being awarded to Dinusha Bandara, a fresh face on the list of recent recipients!

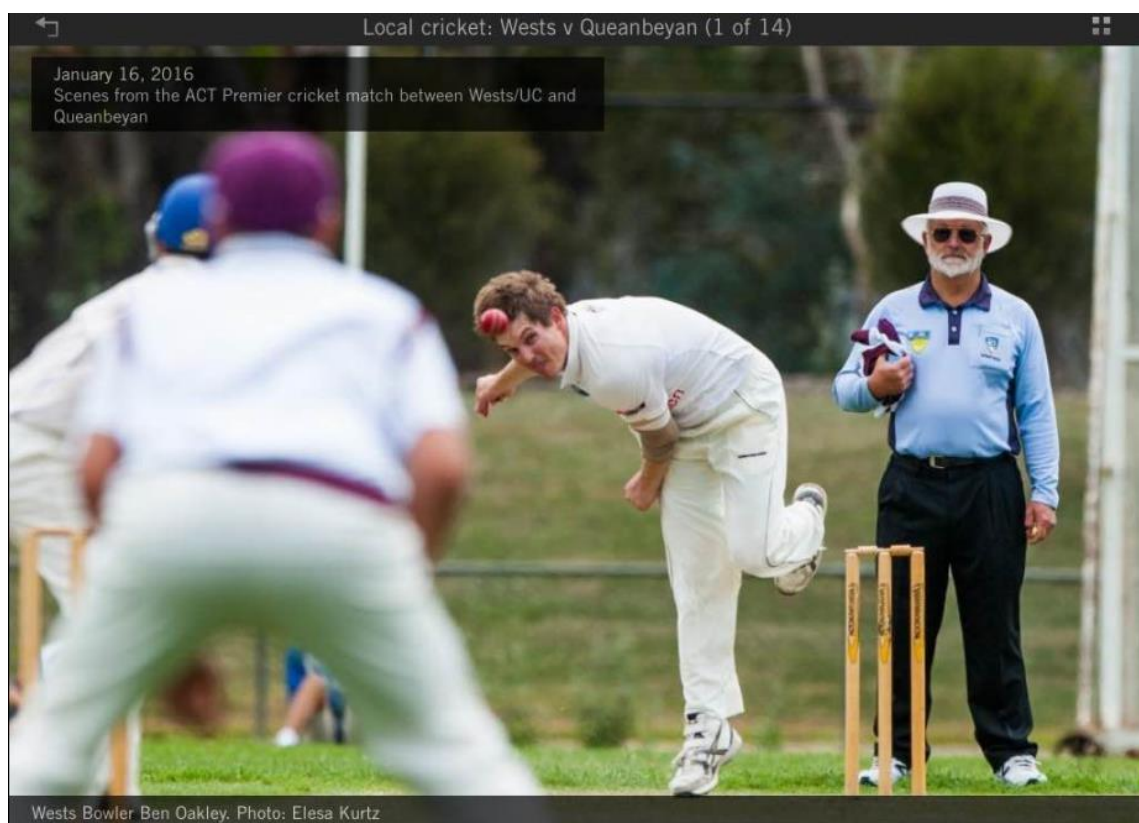
It is beneficial to an organisation such as ours to look back as well as forward, to draw on the experiences of our predecessors, and to learn lessons from the past. This is in part facilitated by the recognition of previous luminaries of the Council (and its precursor Association) by the names associated with our Annual Awards. The awards winners were recognised at the Council's Annual Awards night held at the Uni Pub which has become our venue for meetings, and who have done us proud yet again this season.

Earlier this year we mourned the passing of former Leo Wyche, a long-standing umpire known to those of us who umpired last century. Leo was always friendly and supportive towards newer umpires, and was a good mentor to many of us in that era. He started umpiring in Sydney in the 1970s, and was a member of our Association/ Council from the early 1980s through to mid-1990s, including 3 years as Umpires Adviser.

As the Executive Committee's and other office bearers' reports that follow describe many of the season's activities and issues, I will avoid repetition. We have had a number of difficult issues to grapple with, some not resolved as satisfactorily as I would have wished, leaving me with a sense of personal under-achievement. C'est la vie.

A proposal is being progressed, with the possibility of the Umpire High Performance Manager's responsibilities being expanded, along the lines of player development in the greater region, as is undertaken by ACT Cricket development staff. This is subject to on-going discussions between ACT Cricket, CA and NSW, and is in its very early stages at this time. I envisage that there could be a significant number of working days' involvement in this (10 to 20 annually, say), which would merit payment for those days, but such financial matters would be addressed as part of on-going deliberations.

In closing I would like to express my sincere thanks to members of the Executive, as we have had a busy season with a number of matters to address. Also, my thanks are extended to other office bearers, and generally umpires at large, for the support given to me as Chair, and for mostly positive contributions to Council operations and constructive discussions at meetings.

## EXECUTIVE COMMITTEE

The Council's Executive consists of its Chairman, Deputy Chairman, Finance Officer, Secretary, Scorers' Representative and the High Performance Manager (Umpires). The HPM is also the representative of the Cricket ACT Board on the Executive. At times during the season, other Council office holders were invited to attend meetings of the Executive Committee when relevant matters were to be discussed. There is also a standing invitation to any member of the Council to attend Executive Meetings as an observer and two members took this offer up in 2015-16.

The Executive Committee convened on 9 occasions during 2015-16. Meetings were usually held on the second Wednesday of the month at the Uni-Pub, Civic. Agenda for, and minutes of, these meetings were meant to be routinely posted on the Council's web site ([www.actumpires.com](http://www.actumpires.com)) as a way of facilitating the accountability of elected office holders, as well as keeping members informed about the issues being considered by the Executive. Once again, this did not work quite as well as intended and greater efforts must be made next year to improve performance on this key governance indicator.

An initiative to keep members informed of developments in a less formal way – an electronic newsletter entitled "Things to Ponder as You Walk to Square Leg and the Scorers Wave Back to You" – was produced by the Deputy Chairman in the first half of the season. The topical and light hearted email gained a good readership among members. Unfortunately, due to work commitments, production could not be sustained into the second half of the season.

While not all Executive office holders were able to attend all meetings during the year (Table 1 below), the overall attendance record was extremely high.

In Adam Morehouse's absence due to personal circumstances, Catherine Polglase continued to act as a standing proxy at these meetings.

## General Meetings

Including the Annual Seminar, six General Meetings of the Council were held between September 2015 and February 2016 and were convened on the third Monday of relevant months. The December General Meeting once again morphed into a very well attended Christmas social function at the Uni Pub. There was no meeting of members in March 2016 so as to facilitate attendance by them at the Council's Annual Dinner and Awards evening and no meeting in April 2016 because of the historical difficulty in achieving a quorum at previous April meetings.

The effort to focus the agenda of these meetings on real match day situations, field-craft, 'practical umpiring', including Laws/rules and umpiring-related developments within CA and the ACTCA was again continued. Some meetings were extremely interesting and the effort to attract guest speakers - in 2015-16 representatives from the Women's Council and Darren Goodger from Cricket NSW - proved popular and interesting.

A combined total of 186 members attended these six meetings, giving rise to an average attendance of 31 members, further reflecting a continuation of improved member participation which has been a consistent feature of the business of the Council over recent years.

## Membership

There was a significant increase in membership of the Council and it was fortunate indeed in that it was able to recruit, train and regularly appoint to games a number of new and younger members.

In its last three or four Annual Reports, the Council highlighted the fact that it is heavily reliant on the regular availability of about 20 members (or about half of the total number of standing umpires). During 2015-16, this trend was reversed and the coverage of matches was spread over a much larger umpire base. While the table below is self-explanatory, it is worthy of further comment.

This table reflects that 25 members stood on a minimum of 16.8 days during 2015-16. Those numbers are broadly around the trend since 2001-02. Taking that into account 2015-16, compared to the previous seasons, again reflected a much greater propensity of active members to share the umpiring workload, offset by the fact that a number of members stood very infrequently.

The main reason why the number of mean days stood by an active umpires has dropped so significantly, is the increase in the number of members who did not stand on many days. For example, 12 members stood on 10 days or less and nine stood on 5 days or less. What the increase in active members has allowed the Council to do during 2015-16 is to appoint to more matches; an increase of 17.8% over the previous season.

Overall, this year reflected an extremely good participation outcome for the Council. In addition, with the increased number of representative and other non-grade game played in Canberra during the season, and which needed to be appointed to, the Appointments Panel, and the High Performance Manager, was constantly busy. However, our increased active member base still made it impossible for the Council to be able to appoint to all Premier games played on Saturdays. See associated report from the Manager, Appointments.

In each of its Annual Reports of recent years, the Council has made the observation that the age profile of the current membership is, or should be, of significant concern. That concern eased somewhat in 2013-14 and, pleasingly, the cohort of members recruited this season is generally young overall and that bodes well for the Council. At the same time, the now, medium and long term recruitment focus of the Council must remain on garnering and retaining younger members.

### **Some of the Issues Discussed by the Executive during the Year**

The Executive discussed a number of substantive issues during the year, including:

- The changing nature of the role of the High Performance Manager
- Membership of the Council.
- Finances of the Council
- Migration of the Council website to the CACT portal
- Council equipment for 2015-16
- Inter-connectivity and working relationships between ACTCA and the Council.

### **Other Council Activities**

While membership of the Council has increased significantly, as evidenced elsewhere in this report, recruitment and retention of younger members is a key challenge into the future and remains an ongoing issue of focus for the Executive.

In a volunteer organisation, thanks are due to every member who made any contribution to the burden of umpiring, scoring and/or administration, along with the families, friends and others who missed out on the time and energy that they devoted to ACT cricket. The support provided by those at Cricket ACT should be acknowledged, particularly the very good work of Premier and Junior Competitions Manager, Ben Ryan.

As usual, the season started with the Annual Training Seminar in September, and we are once again indebted to Andrew Shelley and all those who provided assistance on the day. Member

feedback suggests that this Seminar was, as usual, a highly successful one. Significantly, a number of potential new umpires attended and quite a few of them went on to obtain their Level 2 qualification and stand in Council appointed games over the season.

This year's Annual Dinner and Awards Night was again held at 'The Uni Pub' in Civic. This very well attended Council event was put together once again by the experienced organisation team comprised of Barry Thomas and Catherine Polglase. Many thanks again for their marvellous contributions towards what was an enjoyable and successful night. The Awards Committee also deserves accolades for the professional and transparent way in which they performed their task this year. Well done.

In a season in which the ACT's various representative teams achieved significantly on the field of play, it is appropriate to offer our congratulations on their achievements to the members of the ACT Representative Umpires Panel (Yohan Ramasundara, Chris Cassin, Andrew Crozier, Tony Dolin, Kumar Jeyakkumar and Deanne Young), under the expert guidance of Terry Keel in his key role of the Council's High Performance Manager.

However, as ever, the Council's 'core' business remains the appointment of umpires to ACTCA graded matches every Saturday, most Sundays and often mid-week games as well. Umpire appointments is an outcome which takes into account Premier Cricket Committee (PCC) expectations, games which need to be appointed to, relative standard of those games, umpire availability, demonstrated umpire ability, mentoring of new umpires, appointment equity and a number of other often subtle issues which need to be considered. This is not an easy task.

This important and vital responsibility falls to our Appointments Panel, chaired this year by Peter McCann. It is appropriate to record our thanks to Peter and his panel members Yohan Ramasundara, Dave Markham, Terry Keel and Mark Vergano for their very good work during the season.

### **Premier Cricket Committee**

The Council is represented on the Premier Cricket Committee (PCC) by the Deputy Chairman. During the 2015-16 season Cricket ACT took further steps to raise its cricket profile and standards, and the PCC was seen as an important vehicle to help deliver this change. While many issues are club-centric, the PCC has increasingly taken on a strategic focus and the involvement of the Council in a number of these new developments has been significant, e.g. support for U15 matches on turf, recruitment and appointment of scorers, guidelines for standards of player behaviour and interaction with umpires. The fact that the Council has been able to lift its membership numbers and provide extensive coverage of lower grade matches has heightened the Council's standing on the PCC.

Cricket ACT has indicated that in season 2016-17 its relationship with the Council, and its umpires and scorers, will provide a fundamental plank in its platform to transition into a Cricket Australia Premier competition. It is an interesting challenge and an exciting opportunity for our members. The PCC provides a very useful link, not just for the Clubs to clarify rulings on the Laws of the Game, but for Council members to be well informed about the latest administrative developments in, and the moods of, cricket in the ACT.

## FINANCE OFFICER

The outcome for this season was a surplus of \$3,042. The main reason for the surplus was the fact that the expenditure for the Umpires Bonus was this season funded from the Grade Cricket vote and not from the Umpire/Scorer vote.

The income from membership subscriptions has risen from \$3,464 last season to \$4,392. This consisted of 53 full members, 6 associate members and 25 scorer members. The higher than usual number of scorer members is mainly due to 15 scorers officiating at the Under 18 Female Championships held in January.

The major merchandise purchase this season was a stock of umpire hats costing \$1,802. Of this amount, \$1,214 has already been recovered through sales to members. The remaining amount covers stock in hand. Congratulations to Tony Dolin for organising this purchase. Our members look very professional in their new hats.

Income from the Development Levy showed an increase from \$812 in 2014-2015 to \$955. This is a very good outcome, especially as there were no National Championships (to which we supplied umpires) held in Canberra this year. The increase is due to the greatly increased number of available umpires this season. There was an increased number of standing days in Junior Finals (from zero to 43), an increased number of standing days in Women's Grade (from 66 to 73) and an increased number of standing days in Men's Grade (from 606 to 713).

The following table shows the amounts received by umpires during last season.

In 2014-2015, umpires received \$80,113.00 for 812 umpiring days at a daily average of \$98.66.

Finally, the Umpire Bonus system was again operating this season. 16 members received \$214.00 each for a total outlay of \$3,424.00. However, as mentioned above, this expenditure did not come out of the Umpires/Scorers vote.

There were less representative matches this season due to the change in the national women's cricket program which has meant seven less matches to officiate at. In addition to ACT Meteors and ACT Comets matches, scorers were required for a VB Series One Day International, the Prime Minister's XI match and a tour match between a Cricket Australia XI and the touring New Zealand side.

I would like to congratulate Darren Mattison on his appointment to his debut Test Match in Sydney in 2016. Unfortunately the Test Match between Australia and the West Indies was marred by heavy rain but it was still a great achievement for Darren.

Cameron Allen, Liam Baker, Trudi Farji, David Fredericks, Nic McGinniss, Adam Morehouse, Jess Perkovic, Rammanee Shivakkumar and Anne Sutherland were appointed to representative matches in the ACT. Congratulations to Trudi, David, Nic and Jess on making their representative debut this season and we hope that you continue at this level.

## **HIGH PERFORMANCE MANAGER/TERRITORY DIRECTOR OF UMPIRING (HPM/TDU)**

Last season I oversaw a great deal of activity relating to the development and promotion of our representative umpires, and it is pleasing to reflect on the fact that the standard of our representative umpires appears to be improving all the time. The general improvement in the quality of officiating of umpires who represented the ACT at national carnivals and other events hosted and managed by Cricket Australia (CA) last season, was favourably remarked on by CA's Match Officials Manager, Sean Easey. Sean's opinion carries a great deal of sway in the realm of Australian Cricket, so we can be confident that others will sit up and take notice of his views.

CA's observations regarding the generally high standard of representative umpiring for all ACT umpires officially observed this season is testimony to the hard work, commitment and professionalism of our representative umpiring group. My aim as HPM (TDU) is to build on these attributes of our representative umpire group – and also those umpires who aspire to officiate at that level – over the coming seasons, thereby raising the standard of umpiring generally in the Territory.

As well as individual representative panel umpires have performed, in my experience turnover or "churn" of umpires at this level has been inevitable (and indeed can be a positive development), and I fully expect the season ahead to be no exception. It is therefore an exciting time to be an aspiring representative standard umpire in our Council, with opportunities increasing as a result of this expected representative panel turnover, coupled with the expansion of CA's Pathway and pre-Pathway matches in the offing (to wit, the Male and Female Under 15's National Championships and the Australian Country Cricket Championships, to be held at Wollongong this coming season).

Our representative panel last season comprised of: Dinusha Bandara, Chris Cassin, Tony Dolin, Kumar Jeyakkumar, Yohan Ramasundara and Deanne Young. I offer my congratulations on a job well done to each member of our representative panel of umpires from Season 2015-16. Their commitment, hard work and willingness to learn and improve, was reflected in solid and professional on-field performances that generally drew praise from observers, and even hard-to-please captains and players.

Regrettably, there were some casualties during the course of the season, in the guise of Andrew Crozier, who decided to stand down from the panel for personal reasons; and Chris Cassin, who decided to pursue further development opportunities in the cut and thrust of the Sydney Grade competition. I wish both these fine umpires well in their future endeavours, and I hope to see them return to the fold at some stage when the time is right.

There were many on-field highlights for our representative panel of umpires, but of particular significance was Dinusha's excellent debut as a Futures League umpire (not to mention his well-deserved Umpire of the Year award); the impressive performances of Dee, Tony and Dinusha officiating in the revamped Women's' BBL competition matches in Sydney; and Yohan's strong performance in standing in last season's annual Prime Minister's XI match versus India.

The representative panel umpires and I worked diligently throughout the season, adhering to a training and development programme which I developed, designed to hasten and refine their skills and development as cricket umpires preparing to make their marks on the national stage. A key element of this season's development programme saw us engage a professional physical trainer in Melanie Hrusik, who worked with the group each week during the season, rain or shine, helping us improve our physical fitness, stamina and endurance. Mel is a very engaging person and her bubbly personality made our physical exertions less tortuous than

would otherwise be the case, and in fact I think that we can thank her for achieving an average 85% weekly attendance from the group at our sessions each Wednesday; a marked improvement on last season's attendance rate.

The group also focused on improving their knowledge and interpretation of the Laws and playing conditions by participation in two question and answer sessions run by my NSW Cricket Umpires & Scorers Association counterpart and one-time First Class umpire, Darren Goodger. The first of these sessions was held in Goulburn and proved so successful that "Goodge" kindly offered to host a follow-up session in Curtin later in the season, focussing on the modes of dismissal. This latter session was extremely well-received and well-subscribed, with many of our aspiring representative umpires accepting an invitation to attend. To a man – and woman – these attendees commented enthusiastically on how much they enjoyed, and benefited from, their attendance at the Curtin session with "Goodge".

During the season I engaged an organisation called SportsLifeIQ, which ran a workshop for our representative umpires, which concentrated on helping sporting officials cope with mental health issues in a semi-professional sporting context. Again, judging by the favourable feedback received, I consider that the group benefited from their participation in the workshop.

Within the ranks of Cricket Australia there is an increasing focus on making cricket umpiring more professional, and with that in mind, CA has developed a new accreditation system. The new on-line system replaces the previous ad hoc arrangements which were in place, with a national accreditation process designed to ensure all cricket umpires across the nation receive consistent standards of training and qualifications.

Up until this season, accreditation for cricket umpires in the Territory has been seen as a desirable, albeit optional objective. I advocated at meetings of the Council's Executive this past season that our Council stood to benefit from transitioning to a position where we required all our active members to achieve accreditation, under the CA model. As a result, the Executive made a decision to require all active umpire members to achieve accreditation by the commencement of Season 2016-17.

It is pleasing to note that many members have already availed themselves of the opportunity to consolidate their knowledge of the Laws by going on-line and completing the two CA accreditation courses: the entry-level Community Officiating (designed to give a basic understanding of cricket umpiring, targeting "mums and dads" in the main); and the more advanced and comprehensive Representative Officiating course. Depending on individual umpires' circumstances and experience, there may be a cost attached for individuals to achieve accreditation.

In conclusion, I would like to note that the Umpires' Council is fortunate to be blessed with a solid blend of youth and experience among its representative and aspiring umpires. Happily, we look like being in the fortunate situation of being spoilt for choice in deciding which umpires will comprise the 2016-17 Representative Panel, with an influx of umpires new to our ranks coming under notice with consistent, professional displays this season. Given the continued high level of performance and development of our cohort of seasoned officials, this is expected to cause headaches at the selection table; a welcome state of affairs that can only be a good thing for the development of ACT cricket in the long term.

## APPOINTMENTS MANAGER

During the course of the 2015/16 season the Appointments Panel appointed 51 umpires to games. The number of games umpired by these various umpires ranged from three to well over 30. As always the case, a number of umpires were not regularly available – some for instance still play Premier or City and Suburban cricket so that they are only available on Sundays. Many others have varying outside commitments during the season. Fortunately, we were able to recruit well this year with 16 new umpires as well as several relocations from interstate.

Consequently, for the majority of matches played this season, it was possible to appoint two umpires from 1<sup>st</sup> Grade to 4<sup>th</sup> Grade with many 5<sup>th</sup> Grade matches being covered as well. As has been the case over recent years, the Council again consulted with Cricket ACT and the agreed approach this season was to always appoint 2 umpires to 1<sup>st</sup> Grade matches and then cover as many matches as possible in 2<sup>nd</sup> to 4<sup>th</sup> Grade and even 5<sup>th</sup> Grade. Gaps which did appear in the appointments from time to time usually occurred in 2<sup>nd</sup> Grade matches as new umpires were partnered with experienced umpires in lower grades.

The panel also appointed two umpires to all representative games within its remit, such as junior representative games. The panel was also able to appoint two umpires to all women's games.

In making appointments, the panel attempts to spread umpires around, so that each member partners different umpires and officiates different teams as often as possible. This is restricted to some extent by the number of teams in some competitions – for instance an umpire who stands in women's games each Sunday in a six team competition will obviously umpire the same teams a number of times during a season.

Contrary to apparent belief in some circles, the panel pays minor regard to geographical issues in making appointments. While we try to make appointments convenient for standing umpires, no umpire has expressed an unwillingness to stand at any particular ground in Canberra.

The panel has also given consideration to whether broader coverage could be achieved by appointing one umpire to more lower-grade games. This is however not always an ideal solution. For umpires to reach and maintain the requisite standard it is desirable for them to stand frequently with other umpires who act as a sort of quality control mechanism. Lower grades are also where we generally place our less experienced umpires, and the panel is loath to make them stand alone except on rare occasions.

During 2015-16, excluding finals, in all of which two umpires were appointed, the following appointments were made:

We looked at the captains' reports and the marks but in reality we were looking at trends in umpiring rather than a focus on individual decisions or individual matches.

What I can confidently report is that we have a talented cohort of umpires who are engaged, eager to learn and improve and are mindful of their relationships with their fellow umpires and with the teams.

Thank you all for the opportunity of coming back into grass roots cricket which I enjoyed immensely, your camaraderie and together we can keep on improving in 2016-2017.

## UNDER 17 MEN'S NATIONAL CHAMPIONSHIPS

In September 2015, I had the honour of representing the Cricket ACT Umpires and Scorers Council at the National U17 Championships in Brisbane. It was a great honour for me in my third year of umpiring.

The Match Officials were managed by Bob Parry (Cricket Australia Umpire Educator) and assisted by Ian Lock (CA National Umpire Coach). There was sporadic interjection from members of the UHPP. These included Peter Marshall (who I know very well from my Rugby Union days), Daryl Harper (one of my umpiring idols) Bob Stratford & David Talalla. The UHPP have a broad and differing spectrum of the vision of umpiring and it is always interesting to converse with such people

The most rewarding of the whole experience was meeting, standing with, talking and learning from the 9 other umpires from other states. They were an excellent bunch of individuals as well as being very good umpires. I had great respect for the number of years' experience and wealth of knowledge they carried from their resultant experiences.

The weather was pretty good for the whole two weeks (apart from 1 day) with many games being played through warm and humid conditions. On day 2 I umpired with my roommate for the tournament Corey Black. He is a professional wine taster (not a bad job!) from Adelaide with a quirky sense of humour and a very diligent umpire. I enjoyed his company and philosophy on all things cricket (and life). I have attached a picture below which highlights the weather conditions which resulted in the only abandoned day for the tournament. This was taken by the Tournaments Official Photographer and captures the dramatic backdrop which turned into a powerful and game ending electrical hail storm!



I stood with many other umpires during the 2 weeks which included a Teacher from Tasmania, an IT Administrator from Western Australia and a Stud Farm owner from Southern NSW. The varied walks of life and characters are a great distraction from some intense on-field situations which always result in great talking points later in the tournament.

This learning and camaraderie didn't just happen on the field. The ten of us spent a great deal of time together off-field, both socially and in CA-run professional development sessions. During the formal sessions much time was devoted to video feedback and analysis, where we all discovered that the CA cameras don't miss much once the umpires leave the relative safety of the change rooms. The Development day also covered Finger speed and Body language as well as Positioning around the crease.

Discussions also centred on goal setting and the concept of team preparation, with examples given of how ICC match officials prepare as a team for series and tournaments challenging all of our beliefs regarding just when teamwork should begin for us as umpires. After this tournament, we were all left in no doubt that success as umpires depends on teamwork from the moment one is informed of one's appointments.

There was plenty of paperwork to keep you busy late at night with CA targets and reviews required for all of the 8 matches over a 12 day period.

NSW Metro team finished the Championships as deserved winners, with a strong bowling line up and a very illustrious batting line-up which recorded 5 centuries between them over the course of 8 matches.

There is a fine line between what makes a good umpire into a great umpire and the subjectivity between individuals is what makes the precarious job of a match official so difficult. Perception, luck and circumstance all contribute to the achievement of umpires in the Cricket Australia pathway. I have been around sport in various guises in my professional life for 15 years to know this will not change in deciding the relative success of an individual. What is important is integrity in your performance and to know you have succeeded in your own personal goals.

I would like to extend a very sincere thank you to Terry Keel and the appointments committee for putting my name forward for selection in these Championships. I hope to complete my experience of umpiring in a CA pathway tournament environment by sharing freely some of my technical skills and inside knowledge of the requirements needed to reach the next level.

Mt Gambia was a beautiful place to visit and I thoroughly enjoyed my stay and I would recommend checking out the Blue Lake if you ever visit yourself.
